DOG LICENSES ARE REQUIRED BY STATE STATUTE

Contact Bernie Kozlovsky, Town Treasurer (863-2806) for a dog license. An annual license is required for all dogs more than five (5) months old.



A current rabies vaccination certificate must be presented at application.



Fees: \$4.00 for spayed/neutered; \$9.00 for male/female.

Fire News & Controlled Burns

If you are planning a controlled burn, you must call the Brown County Sheriff's Office (448-4200) AND YOUR local Volunteer Fire Department Chief in advance.

Residents East of Dickinson Road must call the Denmark Volunteer Chief Dave Bielinski (920-371-8090) to leave a message.

Residents West of Dickinson Road must call the Morrison Volunteer Chief Bill Lasee (920-864-2501).



Calling ahead will alert all emergency responders of your plans and will alleviate confusion at the 911 call center if someone not involved in the burn would report the fire.

Safe for Firefighters

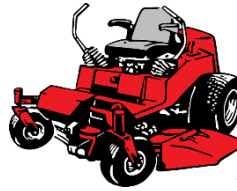
- Is there room near your home for emergency vehicles to turn around?

Safety on the Roads is important all year long. There are several things that all residents need to keep in mind to help keep ourselves and those around us safe, no matter the time of year:

- Wearing bright colored and reflective clothing when biking or walking down the roads in our town to stay safe while staying healthy!
- Please watch for slow moving vehicles and farm equipment on the roads.
- More farmers are using ATV/UTV's on the roads to do their work. Please make sure they are marked for such.



Grass Clippings on the Road and Pushing Snow Across Road

Please keep in mind that it is illegal to blow your grass clippings onto the road or to push your snow across the road. This directly violates Wisconsin State Statutes and is unsafe for drivers and motorcyclists.

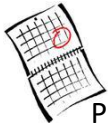

Reminder to Residents from the Zoning Administrator



Prior to considering any rezones, contact the Zoning Administrator, Ben Schauer, before you contact a Surveyor. The Surveyors do not always know all of our regulations.

When considering any changes to your property, including remodeling, new construction, driveways, etc. contact the Zoning Administrator first to find out the requirements of the Glenmore Zoning Ordinance.

If permits are required, the information must be delivered to the Zoning Administrator by the 15th of month 1 to be placed on the Plan Commission agenda of month 2. Final approval comes from the Town Board at its meeting in month 3. **PLAN AHEAD!**

Driveway Permits

A permit is required to construct or enlarge a driveway and/or install, re-install, replace, or move a culvert.

The Town maintains a list of interested residents that would like to serve on the Board of Appeals, Board of Review, Plan Commission or as an Election Worker. **These are all PAID positions.**

to add your name to the list for future consideration.



Monthly Town Board meetings are normally held the first Monday of the month beginning at 7:30 PM.

Plan Commission meetings are normally held the second Tuesday of the month beginning at 7:30 PM, if there are agenda items.

Solid Waste/Recycling Pick-Up is on Monday's starting August 6th, except on legal holidays, Memorial Day and Labor Day, which it will then be on Tuesday.

All notices are posted at the Glenmore Town Hall and glenmorewisconsin.org. As a courtesy, many notices are posted at these additional locations: The Door County Coop-Shirley Feed Mill, and The Farmstead Bar. All notices are sent to website subscribers. To sign up for notices, e-mail glenmoreclerk@yahoo.com and enter subscribe in the subject line.

PROCESS FOR OBTAINING A BUILDING PERMIT

1. Contact the Zoning Administrator first at 920-864-2330 or glenmorezoning@yahoo.com. If the building meets the ordinance codes, a meeting will be set up to fill out the paperwork.
2. Meet with the zoning administrator to fill out the Land Use Application and bring along a sketch of the parcel displaying the proposed building/addition.
3. OTHER Permits that may be required prior to getting the building permit. If within 300 feet of an Environmental Sensitive Area or Shore land, a permit from the county will be required. If 200 feet from a county highway, a County Highway Setback Application/permit will be required.
4. Once all requirements are met the Land Use Application will be signed by the Zoning Administrator, all paperwork will be scanned and sent to the Building Inspector Marty Johnson.
5. Resident or Contractor then should contact Marty Johnson, 920-410-6756 and mjohnson@omro-wi.com to obtain the building permit.

Note from the Chair

As I sit here writing this on another warm early March evening, large amounts of the winter's snow have melted, and spring seems to be around the corner. Then I think back a few years when we got two feet of snow in mid-April and am reminded of how finicky Mother Nature can be, so we'll wait and see what is in store for us this year.

Speaking of spring, we are approaching our Community Clean-up day which will be held on Saturday April 18th, there is more information in this newsletter and more will be posted on the website. There may be changes this year and we are still working to finalize things as some of our options from last year are no longer available. Since we are talking about recycling and garbage, I have been informed by Harter's that with their purchase of a new truck that has been being used in our town for some time now, there are a few options for us on windy pick up days now. It is preferred to put bins out as we were instructed, but if there is a concern of the wind tipping the bins, we may place them with the handle side into the wind to prevent the lid from blowing open. A last resort is to place a 2 or 3 pound stone or piece of wood on cover, I was told when the arm goes out to grasp the bin, it vibrates it enough to knock the weight off, but I have not tried this method yet.

Finally, as the warm weather approaches, days get longer, lawns green up and the ground dries, we will be sharing the roads with our farm friends and neighbors. There may be mud on the road, you might get delayed by a large implement, but I can say with confidence that our farmers do their absolute best to be good neighbors. Keep in mind the stress they are under to get the fieldwork complete in the windows that the aforementioned finicky Mother Nature provides for them, they do the best they can in the majority of cases. If we all show some courtesy and patience, Glenmore will become an even better place to live.

2020 Elections

***Registering to Vote**—Any resident who is new to the Town, or has just turned 18, can register to vote at any time by filling out and returning the EL-131 and Proof of Residency to your Clerk. You must have lived in the Town for a minimum of 10 days prior to the next election to be eligible to vote at that election.

***Absentee Voting By Mail**—Any registered voter may absentee vote for any election by filling out the EL-121 and returning to your Clerk. The application must be received by mail by the Thursday before the election to absentee by mail. Keep in mind, that a copy of your unexpired Photo ID, **must** accompany your Absentee application, if not already on file with the Clerk. (**Exception—Indefinitely confined voters are not required to have a photo ID on file**)



Applications for absentee voting may be sent in any time after January 1st, 2020 for the 2020 Election year! You may apply for one election or all elections this year.

If you have a hard time making it to the elections due to age, disability, illness or infirmity you may request to be on a permanent absentee ballot list. This means that you would be sent a ballot for every election that you are eligible to vote for. Please call Clerk, Cindy Ossmann at 864-3420 and she will assist you in this process.

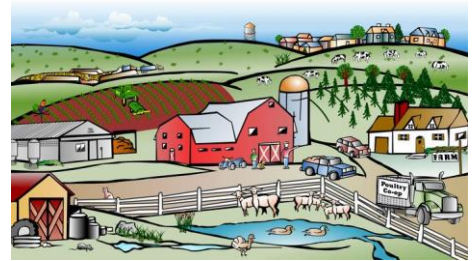
***Absentee Voting In Person**—Any registered voter wishing to absentee vote in person for an upcoming election may do so by contacting Clerk, Cindy Ossmann at (920) 864-3420 or glenmoreclerk@yahoo.com. You will then be able to schedule a time to vote prior to the Election. In-Person Absentee Voting must be completed prior to 5 PM on the Friday before the Election.
